TEMPORARY ONE-WAY CLOSURE ORDER
High Street
Uttoxeter

NOTICE is hereby given that the Staffordshire County Council on the 17th of Decemeber 2024 made an Order the effect of which will be to prohibit any vehicle from proceeding Northbound in that length of High Street in Uttoxeter from outside 59 Red Gables, unless the vehicle is being used in connection with the works; or unless the vehicle requires access to properties on the length of road or is being used for police fire brigade or ambulance purposes.

An alternative route for traffic is available and will be signed on site.

The order will come into operation on 6th January 2025 and the said works will commence on or as near as practicable to that date. It is anticipated that the works will be completed by 10th March 2025.

The Order will remain in force for a period of 18 months, or until the building works which it is proposed to carry out on or near the road have been completed, whichever is the earlier.

(TEMPORARY ONE-WAY CLOSURE) ORDER 2025**

WHEREAS the Staffordshire County Council ("the Council") being the highway authority for High Street in Uttoxeter is satisfied that the traffic on the said road in the East Staffordshire District (B) should be restricted by reason of works in connection with building works being executed or proposed to be executed therein.

NOW THEREFORE the Council in exercise of the powers conferred by the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other enabling powers hereby makes the following Order:-

1. Save as provided in Article 2 of this Order no person shall cause any vehicle to proceeding Northbound in that length of High Street in Uttoxeter, outside 59 Red Gables.
2. The provisions of Article 1 of this Order shall not apply to any vehicle being used for or in connection with the said works; or for vehicles being used for police fire brigade or ambulance purposes or vehicles requiring access to properties on or immediately adjacent to the said length of road.
3. This Order shall come into operation on the 6th January 2025 and may be cited as the Staffordshire County Council High Street in Uttoxeter (Temporary One-Way) Order 2025
4. That the following be the preferred alternative route for traffic affected by this Order namely:-

The preferred alternative route for traffic is available and will be signed on site.
